



## **Utility Contract**

### **Fee Schedule**

Utility bills are mailed on or about the second business day of each month and are payable within 20 days from mailing. A base charge for water/sewage, garbage, and recycling are included at the current rates of \$24.00, \$26.50 and \$10.50, respectively. Water bills are calculated based on a monthly meter reading which will also be used to determine sewage charges. If a temporary shut-off is requested, a \$20 fee will be collected at both the time of shut-off and turn-on of services.

### **Penalties**

All bills are subject to a 14% penalty for payments made after 4:30 PM on the due date. Any account which has been delinquent for more than 30 days is subject to termination and a subsequent \$100 reconnect fee. Prior to termination, all properties will be red-tagged. A \$20 fee will be added to the bill for each red tag placed on the property.

### **Garbage/Recycling**

All garbage/recycling services are curbside only. Items for pickup must be placed within 3 feet of the curb. All loose garbage and trash must be containerized in some manner. Residents are permitted 2 garbage receptacles weekly that can be no larger than 45 gallons and have a maximum weight of 75lbs when full. If necessary, residents are further permitted to dispose of an additional twelve 32-gallon bags (or the equivalent thereof) along with the refuse placed in their standard receptacles. Backyard pickup service is available through the City’s refuse contractor Tri County Industries, Inc. by calling 1-800-457-8202. There will be an extra fee for this service.

Garbage and recycling pickup occurs on a weekly basis and all items must be placed out for collection after 6:00 PM the night prior to pickup. Containers are to be removed from the curbside the same day of collection. If your pickup was not completed on your scheduled day, please call the Utility Department.
